CLOSE GAPS BY 5 WORKS TO STRENGTHEN AND EXPAND PARENT AWARE AS MINNESOTA'S QUALITY FRAMEWORK FOR EARLY CARE AND EDUCATION PROGRAMS BY GROWING THE NUMBER OF AVAILABLE PARENT AWARE RATED EARLY CARE AND EDUCATION PROGRAMS STATEWIDE AND WORKING TO KEEP THE RATING STANDARDS STRONG AND TIED TO WHAT RESEARCH SAYS CHILDREN NEED. THIS APPROACH IS SYSTEMATICALLY IMPROVING THE QUALITY OF EARLY CARE AND EDUCATION PROGRAMS IN MINNESOTA.
